# Our projects in 2021

**IN 2021** we sold 110 new projects and worked on a total of 162 projects in 70 different countries. Our business generated a turnover of EUR 27 million, which represents 38% of FCG Group's turnover. Despite the COVID-19 pandemic, the volume of our business remained on the level of 2020.

Our biggest new projects were under the sector of Good Governance and Public Administration. They include the Sida Framework Agreement for Global Capacity Development Programme on Sustainable Public Procurement, and two other framework projects for the Ministry for Foreign Affairs of Finland. Geographically our strategic focus remained in Africa, Asia and the Pacific.

As the COVID pandemic expanded, we were quick to introduce new ways of working. Together with our clients we found ways to proceed in our assignments despite restrictions. Many of these new practices will remain, helping us to improve productivity even under normal circumstances.

Conflicts in Myanmar, Afghanistan and Ethiopia also affected our business significantly. In 2022 we continue to implement our 2021–24 long-term strategy. We expect business to be affected by the war in Ukraine and COVID-19 in some of our target regions.



### **Challenge to be met**

THE INCREASING household incomes in the Greater Mekong Subregion (GMS) have affected dietary preferences, leading to a rapid growth in demand for livestock products. The escalating demand has consequently increased large-scale movement and trade of livestock. This poses several challenges related to animal health and increases demands for better infrastructure and capacity development to enable increased livestock trade in the GMS countries.

### Aim and impact of our assignment

ment Bank to provide a loan worth USD 238 million to the GMS Region. The aim of the projects was to address challenges in the region through the development of tailored projects for each country, recognising their priority needs around livestock sector growth. The work included carrying out technical, environmental, social, economic and financial due diligence. In addition, the team designed interventions to develop capacity around the livestock sector and gender-responsive policy environment.

**ADB FUNDS** will support this by building relevant infrastructure, increasing capacity in the region, and enabling policies for better supply, health and safe livestock trade.

### **Challenge to be met**

**MONGOLIA IS** a forested nation with boreal forests covering 14 million hectares of its land. Compared to tropical forests, boreal forests store twice as much carbon per hectare making them the Earth's largest terrestrial carbon sink, and a significant factor in mitigating climate change. However, on average, 140,000 hectares of boreal forests in Mongolia are degraded or lost annually. The country is trying to improve its forest management practices and turn the trend to realize the economic and the climate mitigation potentials of its forests.

### Aim and impact of our assignment

**THE AIM** of our project is to increase sustainability and productivity of the forest sector in Mongolia. FCG is responsible for the Technical Assistance (TA) implementation of the project together with the Mongolian Forest Research Association. Our role is to support the Ministry of Environment and Tourism, and to help them to strengthen the national forestry sector development and reform. The practical work of the TA team includes institutional and capacity assessments, legal review and financial assessment, based on which we will prepare a proposal for sector reform strategy, including implementation and financing plans. The Government of Mongolia has recently launched a campaign to plant '1 billion trees' inside and outside forests, to which the TA team contributes by providing guidance on effective sector organization.

### **Challenge to be met**

**THE COMBINED** effects of climate change, unsustainable exploitation of natural resources, and the brown production model have resulted in unprecedented changes to Kenya's ecosystems threatening the agricultural production, food security and the sustainable provision of fresh water sources.

### Aim and impact of our assignment

ter Sector Trust Fund (WSTF) and local governments and communities in rural Kenya in building capacity to manage the water supply, water resources and sanitation in a sustainable way. The FCG team also helped to develop a decentralized decision-making model for the underserved and poor areas with special focus on women and socially disadvantaged groups.

**THROUGH OUR** support, 130,000 people now have access to clean water, and 140,000 people have largely improved hygienic standards through sanitation. Also, 15 water resource plans have been developed in participatory processes. The WSTF and local governments in Kenya have been provided with modern, state of the art tools for monitoring. Water meters have been installed, and the outlook for sustainability of the investments is good.

### **Challenge to be met**

**THERE IS** an increasing pressure to measure the results of development projects more effectively, and to report and assess the impact of the projects accurately. In the Pacific Island countries, the government agencies responsible for delivering projects often lack the needed capacity and resources to carry out such monitoring and evaluation.

### Aim and impact of our assignment

IN 2021, FCG carried out multiple project evaluations in the Pacific Region in partnership with SPC and SPREP. These evaluations were targeted to different kinds of projects, including assessing success of climate change mitigation and adaptation activities at both government and community level. Also, large coastal fishery and aquaculture programs were evaluated.

reg's team is experienced in carrying out such evaluative studies in the Pacific Islands context, which come with many challenges due to the long distances, remoteness and limited resources. The FCG team worked together with government stakeholders and communities to objectively learn the experience from multiple perspectives and assess these against internationally recognised success criteria. The midterm and end-of-project evaluations produced valuable performance information for the project stakeholders.



### **Challenge to be met**

**VANUATU IS** an island country located in the South Pacific Ocean. According to the United Nation's risk index 2021, it is the most at-risk country for natural disasters in the world. Vanuatu is exposed to several disasters which is why increasing resilience is crucial to ensure sustainable future of the Ni-Vanuatu communities.

### Aim and impact of our assignment

**THE FCG** project aims to improve urban and disaster resilience in the capital of Vanuatu (Greater Port Vila) through capacity building, institutional strengthening, and constructing two multipurpose emergency shelters.

our role is to support resilience building through increased management at multiple government agencies responsible for urban planning and infrastructure in GPV, and increasing the disaster resilience of communities through partnerships and community awareness campaigns. Our project team also ensures that the current and new assets are managed and maintained in a sustainable manner to sustain the project impact.

### **Challenge to be met**

PUBLIC PROCUREMENT accounts for an average of 12% of GDP in OECD countries and up to 30% in developing countries. Considering the large sums involved, Sustainable Public Procurement (SPP) and other approaches aiming to improve public procurement procedures and foster strategic spending have a large potential development impact. By integrating social and environmental factors, as well as life-cycle considerations, into the traditional financial calculations, SPP is expected to increase the level of transparency, to fight corruption and to reduce negative impacts on society and environment.

### Aim and impact of our assignment

with the overall objective that SPP will be used as a strategic tool for sustainable development and for the achievement of Agenda 2030, Sida has awarded a framework agreement to FCG. This will allow FCG to plan and implement a global capacity development programme to support increased deployment of sustainable public procurement practices. It will be done first in Sida's partner countries in Africa and Latin America and, after that tentatively also, in Eastern Europe and Asia. The programme will provide handson support and mentorship to reform processes that are linked to SPP. The design of the programme will also differ between the countries and partner organisations engaged in the programme.

### **Challenge to be met**

THE EUROPEAN Union (EU) is the main supporter of Ukrainian Civil Society, the importance of which is growing in Ukraine. The sector is perceived as vibrant and impactful, due to the increasing number of Civil Society Organisations (CSO) and the positive public perception towards civil activity. However, the level of individual participation and civic activism remains rather low.

### Aim and impact of our assignment

**THE AIM** of this EU framework project was to assist the EU Delegation in Kiev in planning and delivering its support to CSOs in Ukraine. These organisations need further support in increasing their absorption capacities, and in developing capabilities in funding diversification, outreach outside larger cities, not-for-profit management, transparency and accountability as well as communication and constituencies building. FCG's project team prepared EU presentations, guidance and synthesis notes as well as a concept note for the EU's future support and presentation for Call for Proposals (for CSO grants). The team also promoted the Call for Proposals by developing and delivering digital sessions for Concept Note development for potential applicants. In addition, the team supported thematic sessions on different topics, and organised forums on societal and behaviour change. They also delivered an update of the EU Civil Society Roadmap and increased and implemented communications activities. The project was highly appreciated by the EU, and this paved the way for the award of a subsequent 3-year project to be launched in March 2022.

### **Challenge to be met**

of the key characteristics of a well-working education system, as teachers have a major impact on improving students' learning outcome. Many developing countries face major challenges in recruiting the best candidates for a teaching career and developing them into high quality instructors.

### Aim and impact of our assignment

**FINLAND AND** Singapore have been successful in promoting learning and producing excellent learning outcomes. Both countries have also invested a lot in education, albeit with different ideological approaches.

FCG WAS tasked by the Asian Development Bank (ADB) to study how to attract qualified and motivated people into teaching, and develop them into high quality instructors and facilitators. Organizing two regional training programmes was also part of the assignment. Likewise, FCG arranged a separate seminar for ADB staff highlighting key issues from the studies and online training, as well as suggested recommendations for further ADB support towards its developing member countries.

**THE PILOT** countries of the study were Finland, Singapore, Sri Lanka and Uzbekistan.



### **Challenge to be met**

THE ACCELERATED Growth for Micro, Small and Medium-Sized Enterprises in Zambia Programme is a private sector development initiative funded by Ministry for Foreign Affairs of Finland and implemented in partnership with the Zambian Ministry of Commerce, Trade and Industry. Evaluation of the programme was needed to understand the effectiveness of the programme that has been running since 2018.

### Aim and impact of our assignment

**THE MAIN** objective of the mid-term review was to analyse the effectiveness and potential impact of the programme and its implementation mechanism. The FCG review team also assessed the need for a no-cost extension of the programme.

**THE REVIEW** of the programme was structured in line with the OECD criteria, which are relevance, effectiveness, efficiency, sustainability and coherence. Programme management and cross-cutting issues were also added to these criteria. As part of the efficiency evaluation, the FCG team undertook a rapid value-for-money assessment. Sustainability was assessed along four dimensions: MSMEs, business development service providers, anchorage and trade links. The review was informative, and it was positively received by the client and stakeholders.

### **Challenge to be met**

THE INDEPENDENT Office of Evaluation of the International Fund for Agricultural Development of the United Nations (IFAD) undertook its first country strategy and programme evaluation in Uzbekistan during 2021, covering the period from 2011–2020. The purpose of the evaluation was to assess the results and performance of the partnership between IFAD and the Government of Uzbekistan.

### Aim and impact of our assignment

worked with a team who evaluated IFAD's overall strategic programme, as well as three loan projects implemented during the ten-year period, working in the sectors of horticulture, dairy production and agricultural value chain development. The evaluation applied standard OECD evaluation criteria. In addition, the evaluation assessed IFAD's contributions to knowledge management, policy dialogue and partnership building, and grants that complement the investments.

**THE COUNTRY** evaluation generated findings and recommendations for future partnership between IFAD and Uzbekistan for enhanced development effectiveness and rural poverty eradication. The report will be used for future strategy development.

# Improving infrastructure in Liberia

### **Challenge to be met**

**BAD ROAD** conditions are a major constraint to economic growth and development in Liberia. The mileage of paved road is limited, and the unpaved road network has deteriorated over the years due to lack of sustained maintenance. Poor road conditions increase transportation fares, vehicle maintenance costs, and compromise food production, especially in rural Liberia.

### Aim and impact of our assignment

THE OVERALL aim of our projects has been to improve opportunities for poor people to enhance their living conditions and livelihoods by providing them with sustainable road access. This is achieved by improving road access, which lets small-scale farmers access markets for their agricultural products and facilitates all year-round social service delivery particularly in the health and education sectors. An important goal has also been to create income earning opportunities for young men and women in rural areas.

So far, the impacts of the project include the following:

- 271 km of feeder road has been rehabilitated, and 800 km of feeder road will be maintained
- Construction of 220 km of Footpath to Track (F2T)
- Construction of several bridges up to 36 meters long
- FCG has trained almost 200 people in different kinds of tasks and assisted in the decentralization of road management into three central county administrations.
